Class 2 – Food premises handling any potentially hazardous unpackaged foods	\$400.00 (plus \$16 per EF T *employee over 10)
Class 2 - Streatrader - Mobile	\$250.00
Class 2a - Class 2 Premises, where the premises is primarily a community group or not for profit organisation	\$185.00
Class 2b - Class 2 Premises, where the premises is a short term seasonal kiosk	\$105.00
Class 2c Community Group - per event (Streatrader)	\$ 30.00
Class 2 & 3 - Temporary Stall (Fixed Premises) Annual fee	\$ 80.00
